4. HX providing, collaborative, symptom focused TX to alleviate DSM-IV symptoms based on medical necessity
5. HX/demonstrated buy-in for managed care philosophy, requirements, treatment
6. HX of using data to measure outcomes/improve performance
7. HX of efficient management of collection/paperwork
8. HX of following procedures, working collaboratively while maintaining appropriate autonomy
9. HX of ongoing professional development
10. Desire for affiliation with a “collaborative professional home,” rather than an autonomous group or independent practice
